OFFICIAL RULES

NO PURCHASE OR PAYMENT OF MONEY IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES.

**SPONSOR/ADMINISTRATOR:** The "2024-2025 Email Newsletter Subscriber" Sweepstakes (the "Sweepstakes") is sponsored and administered by The Oregon Tourism Commission (dba Travel Oregon), 319 SW Washington Street, Suite 700, Portland, OR 97204 (the "Sponsor").

**ELIGIBILITY:** The Sweepstakes is open and offered only to legal residents of the United States and Canada (except Puerto Rico and Quebec and where prohibited by law), who are 21 years of age or older at the time of entry. Employees of Sponsor, and its affiliates and subsidiaries, and their immediate family members (spouse, parent, sibling and their respective spouses, regardless of where they live) or persons living in the same households of such individuals, whether or not related, are not eligible to enter the Sweepstakes or win a prize. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible, illegible, misdirected or postage-due entries, which will be disqualified.

All entries must be received by 11:59:59 p.m. PDT on April 30, 2025 to be eligible for the drawing. Limit one (1) entry per person/email address for the entire Sweepstakes Period. Multiple entries from any person or email address will be void. Entries generated by script, macro or other automated means or by any means that subvert the entry process, as determined in the sole discretion of Sponsor, are void. All entries become of the property of Sponsor.
