TRAVEL OREGON *"FALL 2024 SWEEPSTAKES"* OFFICIAL RULES

NO PURCHASE OR PAYMENT OF MONEY IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES.

SPONSOR/ADMINISTRATOR: The "Fall 2024 Sweepstakes" (the "Sweepstakes") is sponsored and administered by The Oregon Tourism Commission (dba Travel Oregon), 319 SW Washington Street, Suite 700, Portland, OR 97204 (the "Sponsor").
